Complaints. We continue to receive complaints about people speeding especially down Addison Drive and Horsemen's Run. Please drive carefully. Remember the <u>speed limit within</u> <u>our community is 25mph</u>.

We have also received some complaints from your fellow homeowners regarding unsightly lawns. We just want to remind everyone of our covenants and that it is a homeowners responsibility per Article 5.2 that the "Owner thereof, … shall maintain such Lot in a manner consistent with the Community-wide Standard and this Declaration" This means the "prompt removal of all litter, trash, refuse, and waste; lawn mowing on a regular basis; tree and shrub pruning; watering landscaped areas; keeping improvements, and exterior lighting in good repair and working order; keeping lawn and garden areas alive, free of weeds, and attractive…". Please ensure your lawns are mowed periodically; that all waste clippings are removed and not simply blown into the street; and the weeds are not allowed to grow in the street curbing. There are a number of homes within our Community for sale, so please help your neighbors by keep our Community looking neat and clean.
